After resting the dough for 15 minutes, the dough is placed on the extruder and stretched / spread by machine. In the continuation of the line, it is filled with apple filling in one layer, thinned by hand on a strip and frozen in a chamber at -40 ° C. Frozen pie is prepared by hand for packaging and mechanically packed in appropriate packaging. The packaged product is stored in a chamber at -18 ° C.
