A brief description of the technological procedure, the method of eliminating biological hazards and the possible use of auxiliary means	Knead dough from flour quality type 400, water, margarine, liquid sourdough, salt and additive for 16 minutes. After resting the test for 15 minutes, it is placed on the extruder and stretched / separated by machine. In the continuation of the line, it is filled with stuffing of meat in one layer, thinned by hand into trays and frozen in a chamber at -40 ° C. After packaging, the pie is stored in a chamber at -18 ° C.
